

## Big Week Ninja Creami Giveaway - Official Rules

1. **BINDING AGREEMENT:** By participating in this giveaway/sweepstakes, you agree to be bound by these rules ("Official Rules").
2. **NO PURCHASE IS NECESSARY:** NO PURCHASE IS NECESSARY TO ENTER THE GIVEAWAY. A PURCHASE WILL NOT INCREASE YOUR ODDS OF WINNING.
